

RENT-A-VILLAGE AGREEMENT

This Agreement is entered into by and between the following Parties on the date of 15 AUG, 2022.

WHEREAS:

鉴于：

- A. Club Med operates tourist facilities peculiar to the Club Med Group where, in general, accommodation, meals, various sports and entertainment activities are offered as a pre-paid, all-inclusive, multi-day package and where a team of specially trained staff, called Gentils Organisateurs (GOs), are charged with the operation of those facilities.

Club Med 从事 Club Med 集团专有的旅游设施经营活动，主要提供包括住宿、餐饮和各类体育休闲活动在内的一体化预付费多日活动方案。公司拥有经过特别培训的被称为“友善的组织者”（简称 GO）的员工团队，专门负责公司相关旅游设施的运作。

- B. Party A intends to exclusively rent the village (the "Village") as indicated in the Invoice attached hereinafter as Appendix I (the "Invoice") for the time period as indicated in the Invoice (the "Period").

甲方有意于所附附件一确认书("确认书")中所列期间 ("独家租用期") 独家租用确认书中确定的度假村("度假村")。

- C. Club Med and Party A have reached the following agreements with respect to Party A's exclusive rental of the Village during the said time period:

DEFINITIONS

定义:

The following words and phrases shall bear the following meanings:

下列名词或词组的含义规定如下:

- "Participants" means the guests of Party A.
“团员” 意为甲方的客人。
- "Club Med staff" means GO's (Gentils Organisateurs) management team in the Village, PS's (Personnel de Service) local service staff and staff employed by Club Med Sales Offices.
“Club Med 员工” 意为度假村 GO (友善的组织者) 的管理团队, PS (服务团队) 的本地服务员以及受雇于 Club Med 销售部门的员工。
- "Price" means the price mentioned below in section 8.
“价格” 意为本协议第 8 条中所指的价格。

1 EXCLUSIVITY

排他性基础条款

- 1.1 Based on the understanding that the accommodation and activities/facilities shall be used only by the Participants whose names shall have been provided in advance by Party A to Club Med as specified hereinafter, Club Med shall provide the following accommodation and activities/facilities at the Village to Party A.

基于本协议规定的住宿和其他活动或设施仅向甲方预先提供给 Club Med 名单上的团员使用(此名单应符合本协议中对团员的规定)的理解, Club Med 应向甲方提供如下度假村的住宿和其他活动或设施。

- (a) The room night and the number of Participants are listed in the Invoice;

客房数及团员人数详见确认书;

- (b) The detailed information of the Period is set forth in the Invoice. The Parties understand that there might be a number of Participants arriving in the Village earlier than 15:00 on the first day of the Period, which is understandable;

独家租用期的具体信息详见确认书。双方应相互清楚和知晓在独家租用期的第一天很可能会有一定数量的团员在该日 15 时前提前到达, 此情况乃是在可理解发生范围之内。

- 1.2 The Participants shall be entitled to have the exclusive use of the accommodation and activities/facilities within the Village subject to the following terms and conditions:

在遵守如下条件和条款的前提下, 团员享有在度假村内住宿和参加使用其他活动或设施的排他性权利:

- (a) Party A understands and acknowledges that on the first day of the Period, there might be a number of Club Med's clients in the Village who are awaiting their return flights and who might not vacate the Village before 15:00 and that there might be Club Med clients arriving in the Village earlier than 15:00 on the last day of the Period unless otherwise agreed in writing by the Parties;
除双方另行书面签字同意外, 甲方需理解并认可在其独家租用期的第一天的 15 :00 后, 仍可能有一定数量的 Club Med 的客人因回程航班的时间等原因无法在该日 15 :00 前离开度假村, 或者在其独家租用期的最后一天的 15 :00 前可能会有部分 Club Med 的其他客人因去程航班的时间等原因提前到达度假村的情况。
- (b) Club Med, its employees, authorized representatives and contractors shall be entitled to access at any time to any part of the Village.
Club Med、其雇员、授权代表以及供应商有权在任何时候进入度假村的任何地点。
- (c) Club Med may authorize other visitors to access the Village upon prior consent of Party A;
在得到甲方事先同意的前提下, Club Med 方可允许其他访客进入度假村。
- (d) Activities and the use of facilities are subject to their availability and to other provisions set out herein under.

各类活动和设施的使用应遵循其开放时间并符合本协议以下相关条款的规定。

- 1.3 Party A shall be fully and solely responsible for arranging and providing for the Participants the transportation from and/or to the Village and providing full details of the same to Club Med prior to departure.

甲方将负责为所有团员安排提供前往或和离开度假村的交通并在团员出发前告知 Club Med 相关交通的具体信息。

2 ACCOMMODATION AND ACTIVITIES PROVIDED BY CLUB MED

住宿及其他由 Club Med 提供的活动

- 2.1 Club Med shall use its reasonable endeavours to provide accommodation and make available all the activities/facilities at the Village as described in the Club Med brochure current, which shall be an integral part of the Agreement between the Parties, at the time of the stay in the Village.

在团员入住度假村期间，Club Med 应在合理范围内竭力保障提供住宿以及作为双方签订本协议一部分当前 Club Med 宣传册中描述的各项活动和设施能够开放。

- 2.2 Subject to the terms and conditions hereof, the package prices shall include the following product:

在遵循本协议项下有关条件与条款的前提下，总体价格包括如下所含项目的费用：

All-inclusive Package Service, which comprises accommodation, recreational services and meals at Club Med Joyview Resorts , but excluding any additional supplementary services.

All-inclusive Package Service include the following:

Club Med Joyview 一价全包度假产品，包括在 Club Med Joyview 度假村内的住宿、休闲活动和餐饮服务，但不包括任何额外提供的服务；

i. Welcome Drink 欢迎饮品

ii. Accommodation: save otherwise agreed in writing by the Parties, the accommodation shall be provided on king-size or twin-share basis and subject to Party A's own allocation and pre-approved in writing by Club Med.

住宿：除去双方另行书面协商外，Club Med 将提供大床房或双床房的标准住宿并可按照甲方的要求帮助分配房间，但事先需要征得 Club Med 的书面同意。

iii. Three daily meals (breakfast, lunch & dinner) with beer provided for lunch and dinner (scheduled by the Village and subject to change, the Village is entitled to stop or cancel to serve any alcoholic drink at any time to any or all Participants due to health & safety or other reasons in its sole discretion).

每日三餐（早餐、中餐和晚餐）包括中餐和晚餐供应的啤酒（由度假村安排并可做调整，且度假村有权在任何时间基于健康安全或其他因素自行决定停止或取消向个别或全体团员提供酒精类饮品）。

iv. Usage of all available sports and recreational facilities with free instructions (scheduled by the Village and subject to change)

v. Evening entertainment and live performances/shows (scheduled by the Village and subject to change)

晚间娱乐活动及现场表演（由度假村安排并可做调整）

vi. Existing stage, lighting and music facilities for evening entertainment

度假村现有的舞台，灯光音响设施来辅助晚间娱乐活动及表演。

vii. Bar and snacking inclusive service (BSI service) at times of bar opening (scheduled by the Village and subject to change, the Village is entitled to stop or cancel to serve any alcoholic drink at any time to any or all Participants due to health & safety or other reasons in its sole discretion).

在酒吧开放时间提供酒吧饮料和小食服务（由度假村安排并可做调整，且度假村有权在任何时间基于健康安全或其他因素自行决定停止或取消向个别或全体团员提供酒精类饮品）。

Drinks other than those provided during meals and BSI services, personal purchases at the boutique and excursions are not included in the package prices.

其他在已包含用餐和酒吧饮料小食服务外提供的付费酒水饮料或在精品店及村外旅游中的私人消费不包含在总体价格范围内。

2.3 No refunds will be made in respect of available accommodation and activities/facilities, which are available, but not utilised or only utilised in part by Participants.

如团员未使用或者仅部分使用已提供的住宿和活动和相关设施，该部分的费用不作退还处理。

2.4 Club Med reserves the right to withdraw, alter or otherwise modify specific programs, sports facilities or activities in the Village.

Club Med 将保留撤回、替换或更改在度假村内的具体项目和休闲设施或活动的安排的权利。

Accommodation

住宿

2.5 Accommodation shall be provided in king-size or twin-share (one or two people per accommodation) and may allocate by Party A subject to the written confirmation by Club Med.

住宿按照大床或双床房（每间住一或二人）提供，房间分配可由甲方提出但须由 Club Med 书面确认。

- 2.6 Allocation of rooms will be effected by the Club Med planning office in the Village in agreement with Party A prior to the arrival of the Participants.

在甲方的团员到达之前，Club Med 房控部门须与甲方就住宿客房在度假村中的分配达成一致意见。

Meals & Drinks (for product (b))

餐饮（针对产品(b)）

- 2.7 Participants' meals will be provided on a full board basis, ie. 3 daily meals (breakfast, lunch, dinner), with beer provided for lunch and dinner (scheduled by the Village and subject to change, the Village is entitled to stop or cancel to serve any alcoholic drink at any time to any or all Participants due to health & safety or other reasons in its sole discretion), at timings determined by Club Med in agreement with Party A.

度假村为团员提供全部的餐饮服务，包括一日三餐（含早餐、午餐和晚餐），午晚餐时，随餐供应啤酒（由度假村安排并可做调整，且度假村有权在任何时间基于健康安全或其他因素自行决定停止或取消向个别或全体团员提供酒精类饮品），用餐时间由 Club Med 与甲方双方协定。

Facilities

设施

- 2.8 All available sports and recreational facilities with free instructions will be provided for use according to Village schedule and subject to change.

所有度假村内可供使用并提供免费指导的运动及休闲设施可按照规定使用，如有变动按变动后规定使用。

- 2.9 Party A acknowledges that:

甲方确认如下条款：

- (a) Adverse weather and other events of force majeure may result in certain described activities being unavailable or withdrawn without notice; and
由于恶劣天气情况或其他不可抗力因素，既定活动将可能无法进行或在未经通知的情况下被取消；
- (b) Participation in activities and use of facilities are necessarily limited to the number of persons who can (for safety or other reasons) participate in the activities or use the

facilities at any one time as per the applicable rules of relevant activities and the use instructions of the relevant facilities.

参与度假村活动或使用度假村设施的团员必须遵守活动规则和设施使用规则，在同一时间参与的最高人数将会受到限制（出于安全或其他因素考虑）。

For the above reasons, Party A must advise Club Med in writing of specific requirements by 30 days before the commencement of the Period. It is further recommended that Party A obtain the insurance in respect of any particular events which may be organised by Party A or by Club Med on behalf of Party A and which may be subject to availability or cancellation due to adverse weather or other force majeure events beyond either Party's control.

基于上述原因，在独家租赁期开始至少 30 天之前，甲方须将其具体要求书面告知 Club Med。另外建议甲方针对由其自行组织或由 Club Med 为甲方组织的可能因恶劣天气条件或其他不受立约任一方控制的不可抗力因素影响而导致取消的特殊活动项目进行保险。

- 2.10 Village shall provide existing stage, lighting and sound system to facilities the night evening entertainment and live performance/shows. Party A can involve an external contractor to supplement professional equipment in order to achieve better visual/sound effects.

度假村提供现有的舞台，灯光音响设施辅助晚间娱乐表演活动。甲方可以借助其他策划承包商的专业灯光音响器材达到更好的视觉音响效果。

- 2.11 Nightly evening entertainment and live performances/shows will be provided according to Village schedule and subject to change. Subject to the consent of the Village, the Participants will also be able to use the night club facilities on the Village premises.

夜间的娱乐活动以及其他现场表演按照度假村的安排提供并可调整。在得到度假村同意的情况下，团员亦可使用度假村的夜间酒吧设施。

Other Services/Facilities

其他服务/设施

- 2.12 Payment must be made locally for purchases from or use of the following facilities at the Village:

度假村中需由使用者另外现付的购买或者使用的设施如下：

- (a) the bar (Drinks not included in BSI) 酒吧（除 BSI 免费提供的饮料之外的）
- (b) the boutique & any bazaar 精品店及商店
- (c) the SPA 水疗
- (d) the excursions 村外旅游

- (e) the telephone, taxis, car hire services 电话、出租车、汽车租赁
- (f) Sports tuition, equipment hire or other additional services on offer which are expressed to be subject to additional charges as detailed in the Club Med Brochure current at the time of the Period. 需享用在 Club Med 独家租赁期同期的当前宣传册中列明的需支付额外费用的运动指导、设备租赁及其他额外服务。

2.13 For the avoidance of confusion, the above expenditures are not included in the package prices and must be paid locally. Payment of such expenditures must be made by the individual Participant who has incurred the expense either direct to the provider concerned or to the Village prior to his/her departure from the Village, unless prior arrangements for their payment have been organised in writing with Club Med by Party A.

为避免争议，上述这些服务或设施使用的费用不包含在总体价格中，而须另行现付。除非甲方与 Club Med 另行事先书面达成支付安排，由团员个人行为发生的该等费用需团员个人直接支付给提供相关服务的供应商或者在其离开度假村之前支付给度假村。

2.14 Party A shall be the guarantee on individual Participants shall pay the Village on demand (as per the payment method requested by the Village) on such sums which are incurred, such payment shall be paid by Participants prior to departure.

甲方应保证如有某个团员享用度假村服务或使用设施产生该等款项，团员应在未离开度假村前按照甲方与度假村协商一致的方式支付给度假村。

2.15 For the avoidance of confusion, unless expressly agreed by Club Med in writing (subject to such terms as Club Med considers appropriate and separately invoiced), Club Med shall not be responsible for providing any travel facilities for Participants to or from the Village.

为避免争议，除经由 Club Med 书面同意（依据 Club Med 认可费用的条款执行，并另行开票），Club Med 不承担提供任何前往或离开度假村使用的交通工具。

2.16 In the event that any expenses incurred by Party A in the Village, Party A shall assign appointed person to authorise such expenses. Party A shall inform Club Med of the information of such appointed person in advance in writing before commencement of Period. These expenses will be verified by both parties after Period and pay within 14 working days after the Period.

活动中有任何额外的花费支出，甲方应该指定专门的工作人员来授权此类消费，同时，甲方应在独家租用期前以书面形式通知 Club Med 该授权人员信息。这类在度假村产生的额外支出应在独家租用期结束后 14 个工作日内付清。

2.17 Tipping is not required at Club Med.

小费在 Club Med 为非强制性的。

3 CUSTOMISING

定制服务

- 3.1 Party A shall be entitled to place special decorations, set-ups, poster, board and other mantels incorporating logo and other information relevant to the Participants ("Customised Mantels") at the Village provided the prior written permission of Club Med as to the content, size and location of such mantels has been obtained. In the event that such Customized Mantels involve an external contractor, Party A shall also submit the details of their requirements to Club Med for consideration and approval. Despite the foregoing, Party A shall ensure solely that Party A be entitled to or duly authorized to use such Customised Mantels and such Customised Mantels be free from any infringement upon third party.

甲方有权在度假村放置特别的装饰, 调整, 海报招贴, 公告板和其他包含与团员有关的标识和信息等(称为定制材料), 前提为 Club Med 事先书面同意该等定制材料的目录、尺寸和放置地点。若这些定制材料需要外部承包商, 甲方也应同时向 Club Med 提供此等要求的相关细节情况供参考和确认。尽管有本款前述约定, 甲方应当独自确保其有权或者被适当授权使用定制材料且该等定制材料不会侵犯任何第三人权益。

- 3.2 Club Med shall be entitled at any time to remove unconditionally any unauthorised Customised Mantels or any such Customised Mantels which Club Med considers are offensive or detrimental to the image of the Village, Club Med, its guests or its staff without incurring any legal/financial liability against Party A.

Club Med 有权随时无条件移除任何未经允许的定制材料或其他 Club Med 认为冒犯或损害度假村、Club Med 或其客人和其员工形象的定制材料而无需对甲方承担任何法律/财务责任。

- 3.3 Save otherwise expressly agreed by Club Med in writing, Party A shall procure that all Customised Mantels are removed from the Village upon the completion of the Period and make good any damage caused by their use in accordance with Club Med requirements.

除非 Club Med 和甲方以书面形式另行约定, 甲方须保证所有的定制材料会在独家租期届满时全部自度假村清除, 并按照 Club Med 的要求对因其定制材料而对度假村造成的损害进行修复。

- 3.4 Should there be any requirement for storage facilities at the Village, either during, before or after the Period, Club Med will not be held liable for any damage or loss to equipment or mantel incurred.

如需使用度假村的仓储设施，无论是在独家使用期内，还是之前或之后，Club Med 都不对存放其中的设备可能出现的损毁负责。

4 INTELLECTUAL PROPERTY

知识产权

- 4.1 Party A shall not be entitled to use the name “Club Med” or the Club Med Logo or any name or logo of the Club Mediterranean Group and its affiliated companies without the prior written permission of Club Med.

甲方在未经 Club Med 事先书面同意的情况下无权使用 Club Med 的名称、标识或者 Club Mediterranean Group 或其旗下公司的名称或标识。

- 4.2 Party A will supply to Club Med for approval prior to their publication copies or samples of all items in whatever form or media which incorporate the Club Med name and/or logo and describe any Club Med accommodation and facilities to be provided by Party A to Participants. 甲方须事先向 Club Med 提交所有将以各种形式或媒介向团员发布的，可能涉及 Club Med 名称和/或标识，以及含有对 Club Med 的住宿情况和度假村设施有描述性词句的公开宣传资料副本或样本，以获得 Club Med 同意。

- 4.3 Party A acknowledges that all rights in the name “Club Med” and the Club Med logo belong to Club Med. Party A shall not obtain any rights in the Club Med name or logo through any use permitted by this Agreement.

甲方应确认 Club Med 拥有对 “Club Med” 名称和标识的所有权利。甲方不因本协议中规定的许可使用对 Club Med 的名称和标识拥有任何权利。

- 4.4 Party A acknowledges that Club Med could take photos and video upon during the Party A event upon agreement from Party A for Club Med promotional purposes. The photos and video of Party A event and its Participants images might be used in Club Med newsletter, website, wechat and brochure free of charge.

甲方确认 Club Med 可在甲方团队入住活动进行期间在甲方同意下拍照和摄影。有关甲方活动或其团员形象的照片和录像可被免费用于 Club Med 报刊、网站、公众微信以及宣传手册中。

5 COMPLIANCE WITH RULES & REGULATIONS

遵守规章制度

- 5.1 To ensure the health, safety, comfort and peaceful enjoyment of all Participants staying at the Village, Party A agrees:

为确保所有在度假村的团员能享受健康、安全及祥和舒适的度假环境，甲方同意以下内容：

- (a) to be bound by the rules of Club Med governing stays at Club Med villages and the local regulations in force for each village (including but not limited to health and safety rules and regulations), and to comply with Club Med village management's lawful and reasonable instructions and directions; and
遵守 Club Med 有关 Club Med 度假村逗留期间的相关规定以及每个度假村当地须遵守的规章制度（包括但不限于健康和安全的规章制度），同时遵守 Club Med 管理人员合法和合理的指导建议。
- (b) to ensure that each and every Participant behaves in a proper and orderly manner and complies with the said rules, regulations, instructions and directions at all times.
保证每个团员举止得体并有秩序并保证所有团员在任何时候都能遵守上述的规章制度和指导建议。

5.2 In particular, Party A shall ensure that Party A and its Participants shall not commit or cause any of the following acts:

另外，甲方应保证甲方及其团员不会做出或者引发下列行为：

- (a) Disturbance or nuisance to the Club Med village or its guests (eg. causing excessive noise, intrusive behaviour, threatening or abusive behaviour etc.);
扰乱或妨碍 Club Med 或 Club Med 的其他客人（例如：制造过度的噪音，侵犯性的行为，威胁性的或诽谤性的行为等）
- (b) Objectionable, improper or undesirable behaviour or activities (e. g. causing damage and affray, lewd or indecent behaviour, underage drinking, illegal drugs etc.);
导致他人不悦的，不合适的，不受欢迎的举止或行为（例如：破坏或滋事，粗俗或轻佻的行为，低于法定年龄饮酒，使用非法药物等）
- (c) Intoxication (ie. under the excessive influence of alcohol or drugs);
迷醉行为（例如：过度饮酒或服用药物产生的影响）
- (d) Non-payment (for stay or any goods and services purchased or consumed); and
拒绝付款（对于在度假村内逗留以及消耗的物品和享用的服务）；和
- (e) Serious breach of the rules and regulations or non-compliance with lawful and reasonable instructions and directions of the Village management.
严重违反规章制度或不遵守度假村管理人员合理合法的指导和建议

5.3 Club Med is entitled to refuse entry to and to immediately remove any Participants or Party A from the Village without refund or compensation for any of the above acts committed or caused by Party

A or any of its Participants. Club Med further reserves the right to decline any future booking from the same group without any explanations in order to safeguard the safety and tranquillity of its guests.

当发生上述情况时，Club Med 有权拒绝或驱逐任何团员或者甲方，令其离开度假村，并不退还任何费用和做任何补偿。基于保障其他客人安全和安定，Club Med 同时保留无理由拒绝任何今后的来自同一人或团体的预约请求的权利。

- 5.4 Party A's designated representatives shall always be with their Participants and are responsible for its Participants' behaviour and activities at all times. Party A shall be liable for any loss, damage or personal injury that Party A and its Participants may cause at the Village.

甲方的指定代表们应全程陪同其团员并对团员的行为和活动负责。甲方同时应对所有因其或者其团员在度假村造成的任何损失、破坏或人身伤害负责。

6 RESPONSIBILITY

责任

- 6.1 Party A and its Participants participate in the activities and use the facilities at the Village at their own risk. Party A acknowledges that sports and similar activities intrinsically involve risk of physical injury greater than those encountered in daily life and by taking part in sports and other activities Party A and its Participants shall acknowledge and assume the risks inherent therein. Club Med, its subsidiaries, associated companies, affiliates, agents or representatives accept no responsibility, and shall not be liable for any death, injury, illness, damage, loss, accident, expense, delay or other irregularity resulting from a Participant's participation in any activity or use of any of the facilities in the Village.

甲方及其团员在度假村参与活动、使用设施所可能产生的后果应由其自负。甲方确认体育运动及其他类似的活动可能比日常生活有更大的导致身体伤害的可能性，所以参与体育运动或其他类似活动时，度假村工作人员需提前告知甲方团员相关体育运动的危险性。甲方及其活动团员需了解和承担这种内在风险的可能性并自行决定是否参加。Club Med，其分支机构、关联公司、附属企业、代理人或者代表对此不承担任何责任，亦不对任何由于团员在度假村参加任何活动或使用任何设备造成的死亡、人身伤害、病痛、损毁、遗失、意外、费用、延误或其他非正常的情况负责。

- 6.2 Any liability that Club Med may have to Party A and the Participants will be limited to a maximum amount representing the value of the original cost per Participant and any direct expenses incurred by the Participant subject to an overall maximum limit of 1.5 times the value

of the original cost per Participant except in cases of death, illness or injury where no limit of liability is imposed.

任何 Club Med 对甲方和团员负有的义务将设最高限额，该限额代表每个团员的原始成本。同时，除死亡、生病或人身伤害等情况不设限外，对任何团员所负义务的直接费用最高不超过每个团员原始成本的 1.5 倍。

- 6.3 Any failure to comply or delay in complying with these terms and conditions by Club Med which is caused by Acts of God; strikes, boycott or industrial action or dispute; action in compliance with any act, regulation, ordinance, by-law or permit or with any lawful direction, order or request of any responsible authority or court; or any other cause whatsoever reasonably beyond the control of Club Med does not give rise to any claim by Party A against Club Med. 任何由于不可抗力，罢工、抵制、劳工行动或纠纷，符合法律条文、规则、法规、细则或被允许或有合法目的的活动，应职能部门或法院要求或命令，以及其他合理的超过 Club Med 控制能力范围的因素引起的未能履行或未能及时履行 Club Med 应尽义务的情况，甲方无权向 Club Med 提出索赔或起诉。

In case the services under this Agreement include all-inclusive services, Club Med will issue plain fapiao to Party A under the category of "travel service*meal fee" for the all-inclusive part. In case Party A has other add-on services, Club Med will issue fapiao under the category of "travel services".

To secure such extra services, Party A shall notify Club Med of its requirements in writing at least 30 days prior to the commencement of the Period. Any extra services ordered by Party A locally at the Village shall be subject to availability and reasonable notice. Such extra expenses will be verified by both parties after Period and pay within 14 working days after the Period. For the purpose of ensuring proper authorisation, Party A shall notify Club Med no later than 14 days prior to the commencement of the Period of the names of those individuals who are authorised to make requests on Party A's behalf on site.

Party A further agrees and acknowledges that Club Med S.A.S is the "Controller" (as defined in 2016/679/EU – General Data Protection Regulation and, when applicable, in the EU regulation on the protection of individuals with regard to the processing of personal data) of all such personal data, to the extent that such directive applies to processing of data by the Parties.

The use of such personal data will be strictly applicable to relevant laws and regulations. In addition, Club Med will take appropriate technical and organizational measures to protect such personal data from unauthorized or accidental damage, accidental alteration or loss, and unauthorized access or disclosure.

Notices of cancellation shall be sent by first class pre-paid recorded delivery express courier or registered post. Other notices and invoices may be sent by ordinary prepaid post.

The seat of arbitration shall be Shanghai. The number of arbitrators shall be one. The arbitration proceedings shall be conducted in both English and Chinese. The Parties undertake to uphold the arbitral award as final, and it shall be available to either of the Parties to obtain enforcement of the rendered award from any competent courts.
