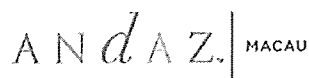

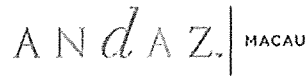
## 11. CANCELLATION IN ITS ENTIRETY

The following charges are applicable for cancellations of the event in its entirety by either party for reasons whatsoever unless it is due to a Force Majeure event. Reasons for cancellations must be sent to the other party in writing. Should the Organization cancel the event for any reasons other than Force Majeure, a cancellation fee as set out in the below table shall apply. ### 14. FORCE MAJEURE

If, for any reason beyond the control of the Resort, including without limitation the generality of the following: any act of God, fire, typhoon, floods, landslides, explosions, war, rebellion, riots, civil commotions, strikes or labour stoppages, act of public enemies, embargoes, epidemics, accidents or mechanical failures, refusal, act of government including suspension or cancellation by any government authority of any licenses, permits or authorization which the Resort has need of to operate or any other event beyond the reasonable control of the Resort, the Resort shall not have any liability to you or your guest(s) for any failure, default or delay in the performance of this agreement.

### 15. PERSONAL DATA

You acknowledge that, to perform the obligations under this Agreement, we may be required to process Personal Data provided and that, in conducting our operations, it may be required to disclose such information to public authorities, affiliates, subsidiaries, external auditors or legal counsels or any related third party in and outside Macau. The Personal Data will be treated as strictly confidential.

### 16. GOVERNING LAW

This Agreement shall be governed and construed in accordance with the laws of Macau and the parties agree to submit to the exclusive jurisdiction of the courts of Macau in the event of any disputes arising from or relating to this Agreement or any breach thereof.

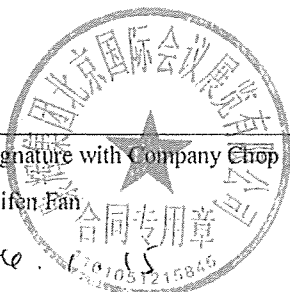
