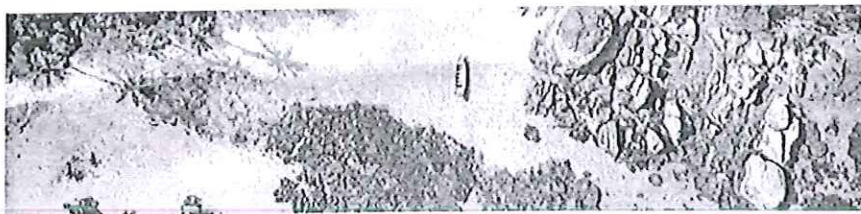

What is a carbon credit or carbon removal credit?

什么是碳信用额度或碳移除信用额度？

A carbon credit is a financial unit of measurement that allows organizations and individuals to support the transition to a low carbon future. Each carbon credit represents the removal or avoidance of one tonne of carbon dioxide equivalent (tCO₂e) from the atmosphere - roughly the monthly energy consumption of an average American household.

Certificates are issued for only the extra carbon absorbed after a third-party verification of the product has proven that it is carbon net-negative from cradle-to-gate. After having reduced your emissions as much as you can, purchasing certified carbon credits is another way to take climate action beyond your own area of influence.

Both parties guarantee that they will not secretly solicit, promise to pay or actually pay any commissions, remunerations or rebates directly or indirectly from the other party and any third party related to the business under this contract and its employees, agents, consultants and representatives, or provide any gift or hospitality or other favor. If either party violates the provisions of the above terms, it will be regarded as a serious breach. The non-compliant party has the right to notify the defaulting party in writing to unilaterally terminate this contract, and reserves the right to take further legal measures according to law. To make up for the loss of the non-compliant party, the defaulting party should also increase the liquidated damages to make up for all the economic losses suffered by the non-compliant party.

Non-Compliance 不遵从情况

If the required deposits or payments are not received by the date indicated, regrettably the reservation for the Group may be subject to cancellation without prior notice. Reinstatement of the reservation can only be made upon receipt of payment and to the extent that rooms and catering space are then available.

Decoration 装饰

To enable the Hotel to maintain our standard of presentation, we reserve the right to refuse any banners, backdrop or signage that are brought in without prior consent by the Hotel.

Delivery & Condition of Storage 运输和仓储

Kindly advise us in advance the schedule of delivery of meeting materials, decoration items or equipment so that arrangements can be made to assist the delivery through the Hotel receiving area.

Articles are kept in the storage at the owner's risk and the Hotel shall not be responsible for valuables or money left in the storage.

If the articles are not claimed within 7 days after the last day of organized event, the Hotel shall be entitled to dispose the articles in any way it deems fit without any liability whatsoever.

The Hotel shall be indemnified by the owner of the articles, for any loss or damage suffered by the Hotel or to any third party, howsoever caused by or in connection with the articles stored in the storage.

Damage 损坏

Liability Contract must be signed and agreed upon prior the commencing of any work to be carried out within the Hotel's premises. The Hotel has every right to refuse entry to any contractors engaged by the Company, should the Liability Contract is not signed and return to the Hotel in time for the work to be carried out. Should there be any damage to the Hotel property during the contracted period which are directly caused by the Company or by the contractors engaged by the Company, the agreed party shall assumes the entire responsibility and liability for losses, damage, claims, demands and expenses arising during the contracted work period.

Fire and Safety Regulations 安全及防火规定

In order to ensure the safety of our guests, the Hotel requests the Company and any outside contractors hired by the Company adhere to the Hotel regulations. The obstruction of any fire escapes inside the Ball room or any Function Rooms by chairs, stages, equipment etc. are not permitted under any circumstances.

In addition, the Company must inform the hotel of any use of flammable materials in the Ballroom and Function Rooms together with the quantities involved well in advance and such flammable materials may only be used with the permission of the Hotel.

Security 安全保卫

The Hotel will provide normal security to ensure orderly running of the event. The Company should at its own cost arrange security to ensure safety of the items displayed/exhibited. The safekeeping of the items to be placed for display/exhibition at all times including prior to and after the event will be the responsibility of the Company. Should armed security guards be involved, the Company has to obtain appropriate license from the local authority at its own cost. Should the above arrangement be required, the Hotel must be informed in advance for necessary co-ordination and assistance.

Sound Effect 音响

The Hotel must be notified at least 3 working days prior to the actual event date for use of any professional sound and audio equipment. The Hotel reserves the right to refuse or prohibit the use of the sound equipment anticipated to cause noise disturbance to other functions during rehearsal or on the actual day of the event.

However, in the event of non-performance due to the above reasons, the Hotel shall refund in full the deposit received for this function.

Agents, contractors, members or participants (as applicable), provided that with respect to officers, directors, employees, and agents, such individuals are acting within the scope of their employment or agency, as applicable.




