

3rd Supplementary Agreement Of
Service Agreement

This Supplementary Agreement (hereinafter referred to as the "**Agreement**") is entered into on 28 of November, 2017 ("**Effective Date**") in Beijing by and between:

Volkswagen Group Import Company Limited (hereinafter referred to as "**Party A**"), a wholly foreign-owned limited liability company duly registered and validly existing under the laws of the People's Republic of China ("**China**") with its registered address being at Room 519-3, No.18 Guomao Road, Tianjin Free Trade Zone, Tianjin Port, Tianjin 300456, China;

and

China Comfort Travel Group Co. Ltd. (中国康辉旅游集团有限公司), a limited liability company duly registered and validly existing under the laws of China with its registered address being at 15F,Ruichen International Center,No.13 Nongzhanguannanlu,Chaoyang District,Beijing,China ;

Party A and Party B are hereinafter referred to individually as "**the Party**" and collectively as "**the Parties**".

WHEREAS:

- a. The Parties entered into a Service Agreement on 1st of January, 2016 (the contract number is CON-VICAS151118(LD), hereinafter referred to as the "**Service Agreement**", according to which Party A engages Party B to provide venue related accommodation, transportation, tourist, catering and meeting related services ("Services").
- b. The Parties entered into a Supplementary Agreement of the Service Agreement on 1st August 2016 with the contract number of CON-VICAS151118(LD)Sup1, hereinafter referred to as the "**1st Supplementary**", according to which both Parties revised the service scope and unit price in the Quotation.
- c. The Parties entered into the 2nd Supplementary Agreement of the Service Agreement on 10th May 2017 with the contract number of

CON-VICAS151118(LD)Sup2, hereinafter referred to as the "2nd Supplementary", according to which both Parties extend the Service Agreement and updated the quantity of Service and Quotation thereof.

- d. The Parties intend to further revise the Service Agreement in accordance with, and subject to, the terms and conditions of this Supplementary Agreement.

THEREFORE, it is hereby agreed between the Parties as follows:

1. Party B changed business name

- 1.1 According to the Official Notice of Name-Changing issued by the Administration for Industry & Commerce of Beijing on 15th of August, 2017, the Chinese Name of Party B has been changed from: 中国康辉旅行社集团有限责任公司 to 中国康辉旅游集团有限公司.

The copy of the Official Notice of Name-Changing please refer to Appendix I.

2. General

- 2.1 Except those amended by this Supplementary Agreement, the terms and provisions of the Service Agreement shall remain unchanged and binding upon the Parties during the term of the Service Agreement and the Supplementary Agreement.
- 2.2 This Supplementary Agreement shall come into effect and be legally binding upon both Parties from the Effective Date. The Supplementary Agreement is an integral part of the Service Agreement and be of equal legal validity.
- 2.3 Except where this Agreement provides otherwise, each Party shall pay its own costs relating to the negotiation, preparation, execution and performance by it of this Agreement and of each document referred to in it. Each Party shall be responsible for its own tax liability arising from the arrangements under this Agreement.
- 2.4 This Agreement is governed by the laws of China. Any dispute arising from this Agreement shall be subject to the dispute resolution procedures provided for in the Service Agreement.
- 2.5 Any amendment to this Agreement is valid only if it is in writing and

signed by or on behalf of both Parties.

2.6 This Agreement is executed in English in four (4) originals and each party shall hold two (2) originals.



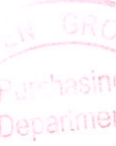
